#### Past RI Vice President Smith dies



Past RI Vice President Dave Smith, 84, of Austin, Texas, USA, died 29 September.

Smith joined the Rotary Club of Austin in 1961. He served as RI

vice president for 1976-77 and as RI director for 1975-76. His service to RI began in 1969-70, when he was governor of District 5780. Smith held other RI positions, including institute moderator, RI training

A longtime radio and television broadcaster and public relations consultant, Smith spent 30 years as a member of the Southwest Conference Football Network. He served as president of the United Press Broadcasters Association of Texas and the Austin Chapter of the Society of Professional Journalists. He was also a member of the Public Relations Society.



During his 60 years in Austin, Smith was active in civic and political life. He was a member and vice president of the Austin School Board in 1964-70 and was appointed by two Texas governors as chair of the Board of Trustees of the Employees Retirement System of Texas.

#### FOUR WAY TEST ESSAY CONTEST: TEACHING ETHICS TO OUR YOUTH by Carol Quick

The Rotary Club of Kissimmee West sponsors a yearly youth essay contest for students in our Osceola District Schools. Three school principals are contacted and given a letter that explains the process. Once the principal agrees to have their school participate a Rotary member meets with one school representative and explains the contest. The essay is based on the Rotarians ethical testing tool that was developed in 1932, by Chicago's businessman Herbert J. Taylor "The Four Way Test".

Students in grade five are asked to write an essay about that they think these four questions mean to them. The top five essays from each school are turned into our club and are judged by a panel of Kissimmee Rotary West's members. They pick one essay from each school and the three winners are invited to one of our meetings along with one parent, their teacher and their principal. This is a total of nine guests (sometimes more) for one of our Rotary meetings. The student reads their essay and then they receive a certificate and a \$100.00 U. S. Savings Bond.

Not only is this an excellent writing assignment, but it further teaches students about the importance of saying the right things and making the right decisions.

The class benefits with a better understanding of good will and business ethics as well as encouraging strong ethical behaviors. They also gain knowledge of Rotary and their high ethical standards.

Hopefully, with this knowledge they will continue to become involved in Rotary in their future years. We've run this contest for five years and everyone enjoys having the students at our meeting and as I speak to the parents,

### ROTARY FAGT

In 1917, RI President Arch C. Klumph proposed that an endowment be set up "for the purpose of doing good in the world." In 1928, when the endowment fund had grown to more than US\$5,000, it was renamed The Rotary Foundation, and it became a distinct entity within Rotary International.

Five Trustees, including Klumph, were appointed to "hold, invest, manage, and administer all of its property . . . as a single trust, for the furtherance of the purposes of RI."

Two years later, the Foundation made its first grant of \$500 to the International Society for Crippled Children.

The organization, created by Rotarian Edgar F. "Daddy" Allen, later grew into the Easter Seals.

The Great Depression and World War II both impeded the Foundation's growth, but the need for lasting world peace generated great postwar interest in its development. After Rotary's founder, Paul P. Harris, died in 1947, contributions began pouring into Rotary International, and the Paul Harris Memorial Fund was created to build
